Privacy Policy

This Privacy Policy describes Batch Gueye's ("Batch Gueye", "we" or "us") practices regarding the collection, use and disclosure of the information we collect from and about you when you use Batch Gueye 's website or sign up for free music.

By accessing or using our website or becoming part of our mailing list, you agree that you have read and understand this Privacy Policy and that you accept and consent to the privacy practices and uses or disclosures of information about you that are described herein.

Information We Automatically Collect

In order to deliver personalized and relevant information to you through our websites, we collect certain information from users. Please do not provide any sensitive information or health information. We do not want, nor will we ask for sensitive information. Batch Gueye's web presence is not designed to process sensitive information. We collect personal information, such as your name, email address, phone number, contact information and location when you opt in to our mailing list. We may also deliver surveys and inquire about voluntary client testimonials. If you make a purchase, we will collect your payment, billing and shipping information.

Once you leave our website or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy or our website's Terms of Service. When you click on links on our store, they may direct you away from our site. We are not responsible for the privacy practices of other sites and encourage you to read their privacy statements.

How We Use Cookies

We use "cookies" on this site. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. Cookies enable us to track and target the interests of our users. We use cookies to compile aggregate data about site traffic and site interactions, in order to improve the user experience and our products and services, to offer better site experiences in the future.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. If you turn cookies off, some features will be disabled, and some of the features that make Batch Gueye's website experience more efficient may not function properly.

Clear GIFs, pixel tags and other technologies.

Clear GIFs are tiny graphics with a unique identifier, similar in function to cookies. In contrast to cookies, which are stored on your computer's hard drive, clear GIFs are embedded invisibly on web pages. We may use clear GIFs (a.k.a. web beacons, web bugs or pixel tags) in connection with Batch Gueye websites to, among other things, track the activities of visitors and users, help us manage content, and compile statistics about usage of our websites. We and our third-party service providers also use clear GIFs in HTML emails to our customers, to help us track email response rates, identify when our emails are viewed, and track whether our emails are forwarded.

Third-Party Analytics.

We use automated devices and applications, such as Google Analytics, Facebook Pixels, and Infusionsoft Tracking to evaluate usage of our websites. We use these tools to help us improve our websites' performance and user experiences. These entities may use cookies and other tracking technologies to perform their services. We do not share your personal information with these third parties.

Do-Not-Track.

Currently, our systems do not recognize browser "do-not-track" requests. You may, however, disable certain tracking as discussed in this policy (e.g., by disabling cookies).

Use of Your Information.

We use the information we collect about you:

To contact you for marketing purposes, including to send you personalized and relevant information through email and text messaging in accordance with local law and consent requirements. You may unsubscribe from our mailing lists at any time by using the "unsubscribe" feature in any marketing emails you receive from us.

We may use the information we collect from you in the following ways:

To personalize your experience and to allow us to deliver the type of content and product offerings in which you are most interested.

To ask for ratings and reviews of our services and products.

To improve Batch Gueye websites in order to better serve you.

To comply with applicable legal obligations, including responding to a subpoena or court order.

Where we believe it is necessary to investigate, prevent or take action regarding illegal activities, suspected fraud, situations involving potential threats to the safety of any person or violations of our Terms of Use or this Policy.

Security.

We take reasonable precautions to protect your personal information, to make sure it is not inappropriately lost, misused, accessed, disclosed, altered or destroyed. Only employees who need the information to perform a specific job are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment. Nonetheless, the transmission of information via the Internet is not completely secure and therefore we cannot guarantee the security of data sent to us electronically, and transmission of such data is therefore entirely at your own risk.

Disclosing Your Information.

We do not share your personal information you enter into our websites or webforms for third-party marketing use. However, we may disclose the information we collect from you to third-

party vendors, service providers, contractors or agents who perform functions on our behalf. We take appropriate steps to ensure that such third parties treat your personal information with the same consideration that we do. We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information.

Batch Gueye is a company based in the United Kingdom. In accordance with local laws, we will take steps to ensure that your personal information receives an adequate level of protection as required by applicable law.

We may also share information in the following circumstances:

Business Transfers. If we are acquired by or merged with another company, if substantially all of our assets are transferred to another company, or as part of a bankruptcy proceeding, we may transfer the information we have collected from you to the other company.

Third-Party Websites and Interaction.

Batch Gueye websites may contain links to third-party websites or applications which are outside our control and are not covered by this Privacy Policy. If you access other sites or applications using the links provided, the operators of those sites may collect information from you which will be used by them in accordance with their privacy policy and terms of use, which may differ from ours. We do not accept any responsibility or liability for their policies whatsoever as we have no control over them.

Users Only of Legal Age of Majority.

Batch Gueye websites are designed and may only be used by those who have reached the age of majority (18 years of age in most jurisdictions). By entering information on our websites, you affirm that you are at least 18 years of age or older. We are not liable for any damages that may result from a user's misrepresentation of age.
